VK Gautam) and membership fee. ➤ Total members are 22, including 06 family members. ➤ 08 schools/college sponsored (@ Rs. 5K to 15K-PA), that comes to Rs. 90K. ➤ 07 PwIDD sponsored @ Rs. 12K PA, paid quarterly that comes to Rs. 84K. ➤ Widows-03 paid @ Rs. 3K PA on Widows Day in Oct that comes to Rs. 09K. <p>❖ Corpus Reserve:</p> <ul style="list-style-type: none"> ➤ As in Dec, 2022, Rs.13.14L in TGCT as Corpus (Meaning thereby; only interest can be used not the principal), targeted 25L by 2025. ➤ Rs. 20L in S/B a/c of Ms. Teena Gautam + Legal Guardian (Meenu), (Sources are; monthly Rs. 11K+ by *VKG, Membership fee-02-25K, + good gesture by relatives or close associates/ friends), since Teena cannot get married or fully dependent or she is innocent or an empathetic approach. <p>❖ Awards Instituted:</p> <ul style="list-style-type: none"> ➤ (Corpus of 3.5L by *VKG. with PARIVAAR-New Delhi BMG award is awarded annually during NPM to the best NGO out of 350 in the country. ➤ International award given to a Philanthropist of India, during International Conference in Indore.
